## **SPECIAL CATEGORY EXHIBITION SUBMISSION SCHEDULE AND CHARGES (COMBINED SHIPPING)**

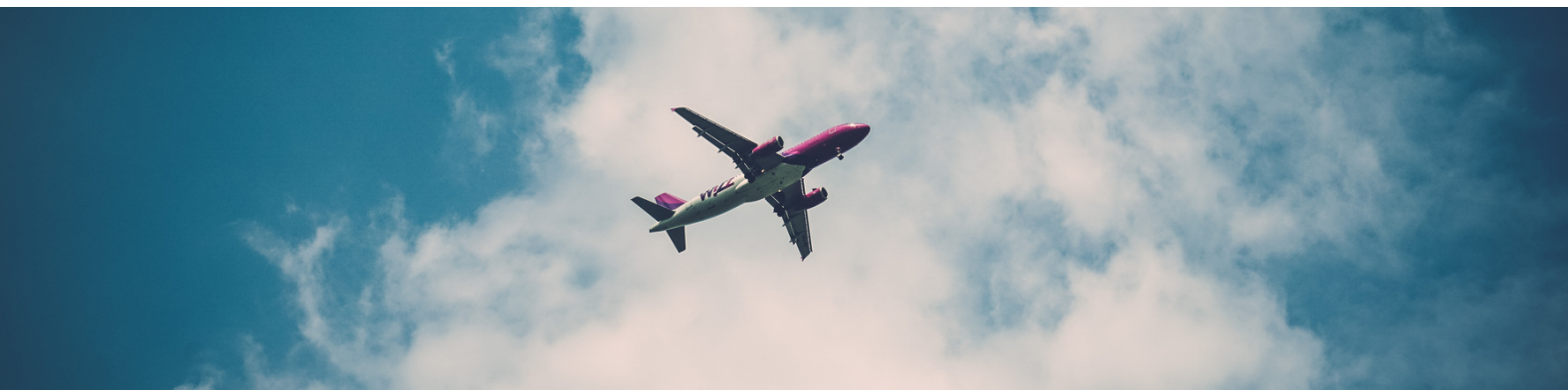
- 1- Mumbai- Chile (Valparaíso Port) - Charges LCL applicable to the Indian market at the time of booking.
- 2- Packing, if applicable: Actual charges
- 3- Forwarding and customs clearance of local shipping agent Mumbai – Indian rupees approximately equal to 100 USD.
- 4- Customs duty 6% and local tax 19%
- 5- Charges of customs clearance of the shipping agent in Chile 1.5 USD/KG or 300 UDS per CBM/minimum.
- 6- Port Charges - 50 USD
- 7- Logistics from the port to the storage of events.
- 8- Debit/credit card sweeping charges is 3%.

## **SHIPPING SCHEDULES**

- 1- Local pickup and transportation to shipping agent in India is seven working days.
- 2- Cargo make in order and obtaining preparation for customs clearance is seven working days.
- 3- Time of personalized forwarding dispatch under normal circumstances is five working days.
- 4- Time of regular shipping trip is sixty-five days.
- 5- Customs clearance in Chile is seven days.
- 6- Ground transport from the port to the event warehouse is two working days.

## **NOTE**

- 1- For B2C participants (Sales): all sales will be made with invoices (facility provided by the organizer).
- 2- All participants must provide invoices for paid GST documents/bank LUTs while delivering the material for export.
