BRIEF RULES AND REGULATIONS FOR PARTICIPATION

1) Space Booking:

Application in prescribed format for participation in the BUYERS SELLERS MEET & BUSINESS NETWORKING, Santiago - Chile to be submitted for booking of space. Space is offered in an area of 9 sq. meters.

1a. Applicant is requested to submit their additional requirement while the time of booking space only like accommodation, post landing service, translator, currency exchange, food & tourist information etc.

2) Allotment of space to the Participants:

Submission of application for booking of space does not automatically confirm a right for allotment of space. Approval of application for space will rest with Organizer.

3) Refund of Participation Fee:

(i) Refund of Participation fee will be considered in case of non- Availability of space, rejection of application or cancellation of the participation due to unforeseen circumstances.

(ii) The quit request by the applicant after 3 months will not be entertained. Organizer will make fifty percent refund of the total deposit with in 30days of the last date of the event. The total deposited amount of participation will be considered for refund in case the space is re-allotted in time. The applicable tax will be deducted.

(iii) Non refund will be considered if the withdrawal request is received less than 3 months before the start of the event.

4) General:

(i) Goods of the country origin will only be allowed for display in the event.

(ii) In the event of postponement/abandonment/cancellation of the Fair, or in case of exhibits not being displayed due to any reason beyond the control of the Organizer, it shall not be liable for any loss or liability.

(iii) The space allotted to the approved participants is to be exclusively used by them for display of their exhibits as approved by Organizer. Subletting of space or change in category of the declared goods will not be permitted in any case. Violation of this clause may lead to cancellation of space allotted forfeiting of space rent, security deposit etc.

(iv) The defaulter of payments in prescribed dates of any payment due from the participants, Organizer, reserves the rights to De-bar the applicant company and from participation, in case participant fails to make all the due payments in prescribed given time.

(v) Organizer will not be responsible for any loss or damage to participants due to abnormal condition or abnormal natural climatic condition. Any dispute or differences arising out of these terms and conditions of participation shall be referred to the President, Organizer, whose decision of award shall be final and binding.

5. Participants will be liable for himself in case of any violation of law of the country regarding his stay or trade activities beyond the event code of conduct & undertaking furnished by him
