Participants have to confirm their accommodation reservation in the exhibition country to obtain invitation letter.

- 1.The Premium spaces will be available with 10 percent extra payments.
- 2.The stall selection will be first come first serve basis.
- 3.The priority of selection will be maintained with the date of payment realization.

- 5.Premium members will get priority. Discounts - as per fact sheets

Products import & sales regulations

1. The value of the goods being dispatched through shipping agency should be quoted in US\$ on realistic basis to avoid any issues with customs authorities in exhibition countries. The invoice should be in prescribed format. Each; every product should be tagged with proper specification. The tags formats can be copied from our web.

2. The exhibits to be dispatched for the exhibition should be of high quality. All the goods must be certified with recognized quality check agency.

3. Exhibits which have been cleared through customs and on which custom Duties/Taxes have been paid can only be displayed at the exhibition.

4. Retail sales by exhibitors can only be undertaken with the assistance of DeHoy America SpA, Santiago, Chile.

5. Sales Tax is applicable on the selling price of the item. (The Tax on Import value of Exhibits will not be considered as the Sales tax value).

6. Each exhibitor will be responsible to provide record of actual daily sales undertaken to Import Facilitating Agency in the format to be provided on site, by end of each day.

7. The exhibitors are required to deposit the applicable Tax in advance as per import norms of the country, which is 19% of the product sales.

UNDERTAKING BY THE PARTICIPANT

All the goods including hand carry for purpose of sale or display will be under the name of DeHoy America SpA, Santiago, Chile; all the exhibitor will have sales billing facility under the name of DeHoy America SpA, Santiago, Chile only.

Further we agree to remit the money in company bank account of our country origin, received after realization of sales. The importer company on official records of organizer will provide us such facility thru their official bank

-We agree to pay an additional service charge of 4%, in case of use the cards swapping (trans bank) machines, a part of local sales tax.

8. Sales will be immediately stopped and penalty may be imposed in case of non-adherence of local Regulations.

9. DeHoy America SpA, Santiago, Chile., will have the right to take decision, as deemed fit, for any unforeseen situation arising during the event and the decision of DeHoy America SpA, Santiago, Chile, will be final and binding on all exhibitors.

10. No claim/damages can be lodged/filed against DeHoy America SpA, Santiago, Chile., by any Exhibitor in case of non-delivery of shipment at the exhibition due to any unforeseen circumstances or Force-Majeure like national calamities etc.

11. Arbitration and Jurisdiction: All matters of dispute arising out of this shall be governed by Chilean law and subject to Court jurisdiction in Chile. Both the party shall make all effort to resolve any dispute by way of reconciliation.

In the event of any question, dispute or difference arising under the agreement in connection therewith (except as to matters, the decision to which is specifically provided under this agreement) remains unresolved; the same shall be referred to sole arbitration of the President, DeHoy America SpA, Santiago, Chile., and the decision given under the provision of the Chilean Arbitration acts shall be binding both the parties. Upon any and every reference as aforesaid, the assessment of costs and incidental expenses in the proceedings for the award shall be at the discretion of the President, DeHoy America SpA, Santiago, Chile.
